I would like to extend a warm welcome to one and all for witnessing the spectacular event – India Rubber Expo 2024

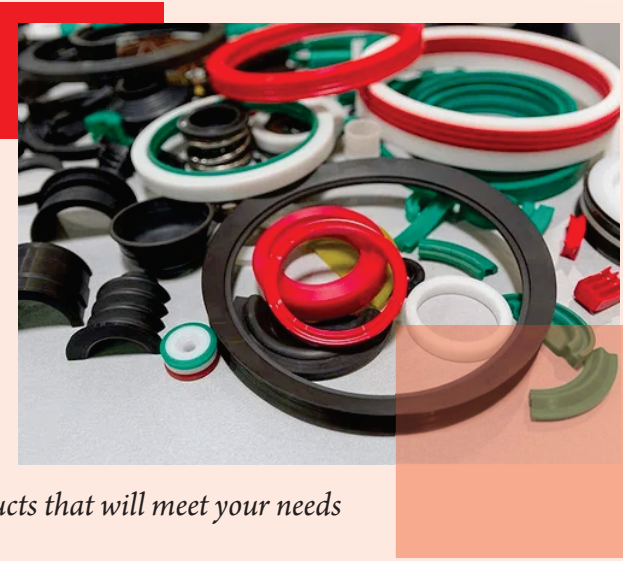

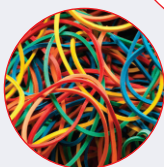

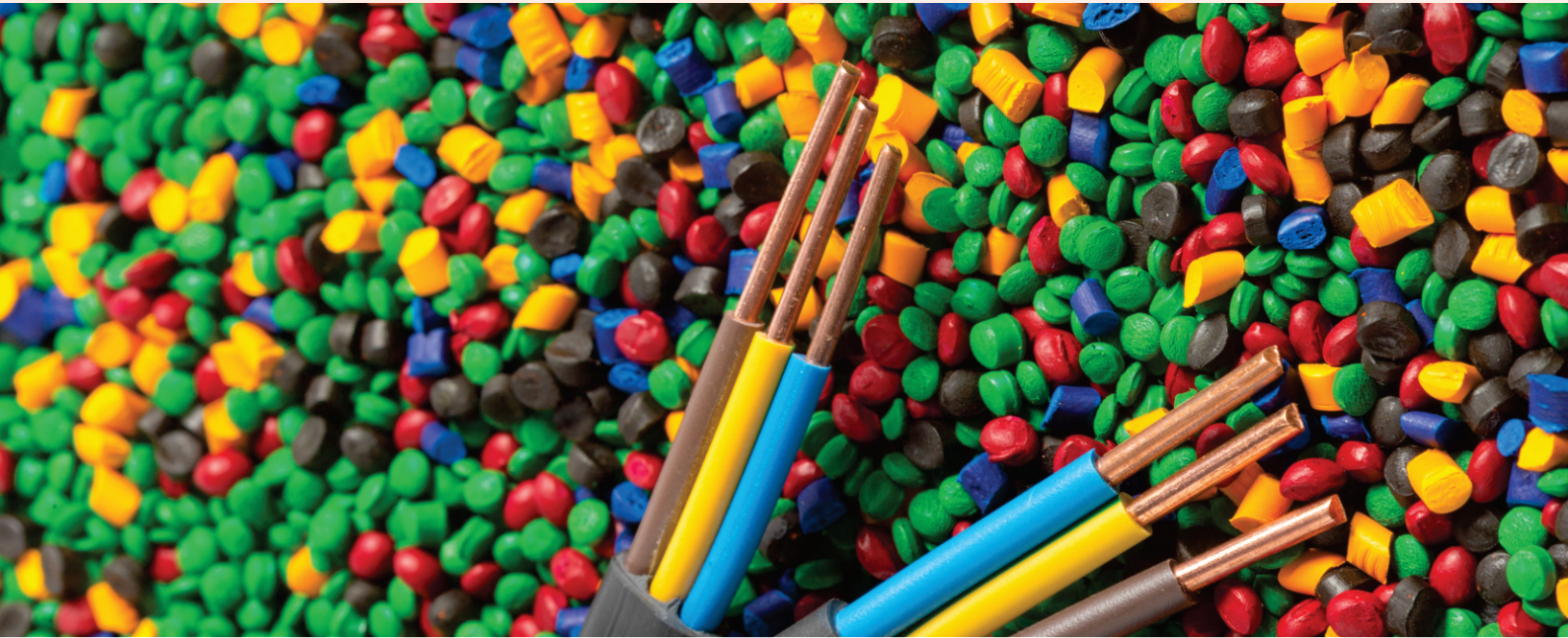
